

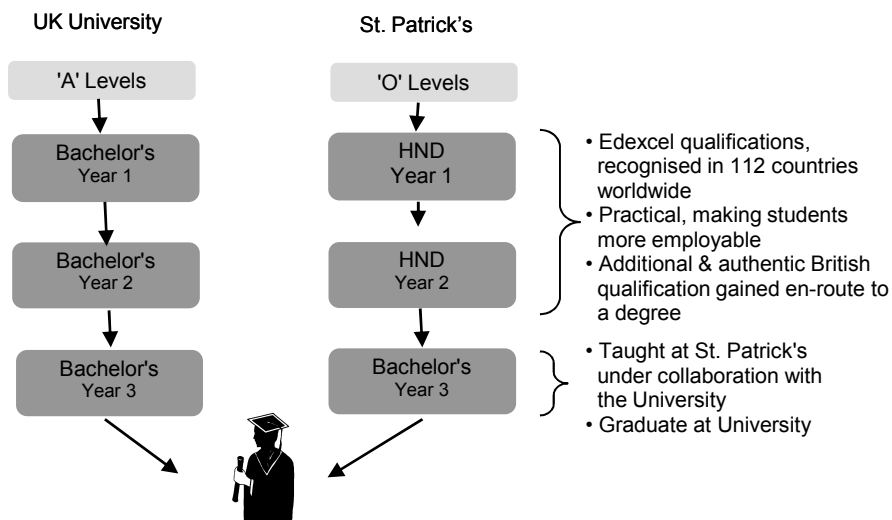

FEEES FOR FULL TIME COURSES, STARTING SEPTEMBER 2010

How our undergraduate courses work

Generally, undergraduate level studies in the UK are 3 years in duration. For most of our undergraduate level courses, St. Patrick's provides a unique blend of academic and vocational learning. In the first two years, students will study for and achieve the Higher National Diploma (HND), this being an internationally recognised qualification from Edexcel (BTEC). Upon successful completion of the HND, students can study for the final year of a Bachelor's degree from a UK university (such as Sunderland or Portsmouth), also taught at St. Patrick's or indeed at numerous other Universities in the UK or aboard. In this way, students achieve dual and authentic British qualifications, without having to leave St. Patrick's.
